Dealers must be NCNA members. Persons not NCNA members should add \$10 to their payment.

Dealers may not sublet or share space without the permission of the bourse chairman. All persons on floor during non-public hours and all persons behind tables must have badges with their full name. Dealer badges are limited to one more than the number of tables on a contract. Dealers must request changes in badges ten days in advance or incur a \$25 fee.

Refunds after September 1 will be made at the discretion of the bourse chairman.

Dealers returning their contracts with full payment by August 1, 2008 will be assured their previous location if desired.

NCNA will provide badges, table sign, and access to electric power. No table covers are provided.

Dealers must have and display a North Carolina Merchants Certificate of Registration. Applications (no charge) are available on request. Due to severe penalties, no dealer will be allowed to set up without certificate or application. All retail sales are subject to North Carolina Sales Tax.

DEALERS MUST USE UL APPROVED, COMMERCIAL GRADE, GROUNDED EXTENSION CORDS..
